# Education and Awareness for Stakeholders

# Networking and Collaborative Partnerships

- Guest presentations for the Governor's Healthcare Workforce Retention Initiative task group, meetings of nurse educators, Oregon State Board of Nursing and to community groups.
- EMS Summit (Assisted Living and EMS partnership) to reduce injury risk from patient handling (LERC).
- Representatives on the Occupational Public Health Program (OPHP) for worker injury and illness prevention.

#### Impacting Curriculum

- State Nursing Assistant Curriculum revised to include safe patient handling (SPH) concepts and use of lift and positioning devices.
- Implementation of the national SPH curriculum into a majority of Schools of Nursing in Oregon (facilitated by ONA).
- EMS/Firefighters Exploring integration of ergonomics principles in EMT training requirements at the state level (LERC).

#### **Resources and Training**

- Health care ergonomics website developed in 2010
- OCHE member organizations offer training, resource materials, and free ergonomics consulting (ONA, SAIF, Liberty NW, Oregon OSHA).
- SPH training materials and videos developed for Acute and Long Term Care health care workers, patients and their families with grants from Oregon OSHA (ONA, LERC, OROSHA, SAIF). Materials are provided at no cost to all acute and long term care facilities in the state.
- Train-the-trainer 8-hour Ergonomics Curriculum developed for Emergency Medical Services (EMS) and Firefighters (LERC).

#### Needs Assessment and Assessing Impact

- An estimated 65% of Acute Care Facilities (i.e., 80% of Acute Care beds) in Oregon have SPH program initiatives with varying components.
- Conducted a formal survey of Acute and Long Term Care facilities to assess impact of OCHE efforts to reduce MSDs in Oregon (OCHE and OPHP).
- Survey of EMS and Long Term Care facilities in Oregon around issues of SPH and transporting heavy patients (LERC).

#### **Strategic and Creative Incentives**

- Completed pilot projects in support of OR-OSHA Facility of Choice (FOC) SPH program for
  - Critical Access Hospitals (including Home Health and EMS) and Long Term Care.
- Promote use of the Employer at Injury Program and Preferred Worker Program in support of healthcare ergonomics initiatives.
- Explore and develop solutions for obtaining necessary SPH equipment for the Home Care environment.
